Erie abortion facility reopens with new doctor

ABORTIONIST HAS CRIMINAL RECORD

American Women's Services of Erie began doing abortions once again on Friday, April 7. This was the first time abortions were done in Erie since April 2005, when the license of the previous AWS abortionist, Harvey Brookman, was suspended by the PA Board of Medicine.

The new abortionist is Stephen Paul Regec, MD, PA medical license MD020553E.

Dr. Regec had been practicing medicine as an Ob/Gyn in the DuBois-Clearfield-St. Marys area in affiliation with the DuBois Regional Medical Center and Adagio Health, Inc.

Regec is no longer affiliated with Adagio Health, Inc. or the DuBois Regional Medical Center. Regec's affiliation with DRMC was abruptly severed last year.

A photograph of Regec can still be found on the DRMC website at www.drmc.org/phys/regec.jpg. His name,

however, does not appear in the website's "Physician Directory." (The picture was located using the "images" option of the Google search engine, not by directly browsing the DRMC website.)

In 1991, Regec pleaded guilty to three misdemeanor violations of the Controlled Substance, Drug, Device, and Cosmetic Act: one violation of Distribution by a Practitioner to a Drug Dependent Person and two violations of Refusal or Failure to Keep or Furnish Records.

On November 19, 1991, Regec was sentenced on his guilty pleas to a total of \$10,000 in fines plus the costs of prosecution and incarceration for 12 to 24 months. Regec's jail sentence was suspended, and he was placed on criminal probation for 24 months under the supervision of the Clearfield County Probation Department.

Regec's criminal conviction led to further disciplinary action by the PA Board

of Medicine. On January 1, 1992, his license to practice medicine in Pennsylvania was suspended for four months and privileges to prescribe DEA Schedule II and IIN drugs (drugs with a high potential for abuse) were suspended for 15 years. After the four-month suspension of his medical license, Regec was placed on probation for an additional 20 months.

Despite his previous legal and professional problems, there are indications that this doctor, who is 58 years old, is new to the abortion industry. One can only wonder, with a certain amount of sadness, what stresses or disillusion with life might drive a medical professional to resort to killing unborn babies on a wholesale, commercial scale so late in his career.

Churches typically make the carnations available for a suggested donation of \$1.00 each, \$5.00 a half-dozen, and \$10.00 a dozen. Additional donations towards the educational work of People for Life are gratefully accepted.

Other churches prefer different approaches. Some, for instance, take orders from members of their congregations ahead of time. Others buy an exact number of

Local residents respond to abortion facility reopening

Public demonstrations accompanied American Women's Services' first abortion sessions on Friday, April 7 and Saturday, April 8. The demonstrations were fairly well-attended on both days. Approximately 200 phone calls were made and 800 e-mails were sent on April 6 to encourage concerned citizens to come out to the demonstrations.

The number of demonstrators present when the abortionist arrived on Saturday morning was quite impressive, thanks in large part to a big group of young men from St. Mark Seminary, the minor seminary of the Erie Catholic Diocese.

People for Life's Alternative Choices for Women office, just across the hall from the abortion facility, was open late Friday evening and early Saturday morning to provide information about local pregnancy support services and alternatives to abortion.

Several of our most experienced office staffers enthusiastically made themselves available on short notice and graciously devoted portions of the weekend to the pro-life cause, keeping our ACW office open and ready to provide assistance.

ACW will continue to "work overtime" whenever abortions are taking place.

Demonstrations: Help Needed

American Women's Services of Erie is currently doing abortions each Friday (late afternoon and evening) and Saturday (morning and early afternoon). This pattern is expected to continue.

Abortion is the murder of an innocent human being and the victimization of pregnant woman. It is only natural, then, that peaceful and orderly demonstrations are being held on the public sidewalks outside the abortion facility every Friday from 3:00 PM to 6:00 PM and every Saturday from 8:30 AM to 11:30 AM. This schedule will remain in effect as long as AWS continues to do abortions during these times.

It takes at least five or six people to maintain a noticeable pro-life presence and to provide pro-life literature near the two main entrances to the Professional Building parking lot. Unfortunately, even this modest number has proven difficult to maintain during scheduled demonstration times.

Please consider dedicating one morning or afternoon per month or just one hour per

month to the demonstrations.

AWS is located in the 1611 Peach Street Professional Building. Participants should meet on the State Street side of the building.

Please do not park or walk in the Professional Building parking lot. We stay *entirely* off the Professional Building property before, during, and after every demonstration.

Sharing the pro-life message

A new educational presentation about abortion was unveiled last fall by People for Life. ELECTION OF OFFICERS

The annual election meeting of People for Life is scheduled for 7:30 PM, Monday, May 15, 2005. It will

be held at the People for Life Main Office, 1625 West 26th St., Erie, PA. Everyone is welcome. Members whose dues are paid one month in advance of the meeting will be eligible to vote. The nominees are Tim Broderick for president, Jean Hammer for treasurer, David Halligan for secretary, Rose Ann Yadeski for first vice-president, Bob Theiss for second vice-president, and Dale Klobusnik for third vice-president. Additional nominations will be accepted from the floor with the permission of the nominee, who must be a current member of People for Life.

Pro-life candidates endorsed

The PA Pro-Life Federation PAC has endorsed the following Erie area candidates for the PA General Assembly (by House District):

- 1 - Open Seat¹
- 2 - Uncontested Seat
- 3 - State Representative Matthew Good
- 4 - State Representative Curt Sonney
- 5 - State Representative John Evans²
- 6 - State Representative Teresa Forcier

(1) The 1st District has an open seat, and a very interesting race is in progress. Democratic candidates Patrick J. Harkins and Dennis Iaquina responded to the PPLF PAC questionnaire and indicated pro-life positions. No response has been received

from Democrat Michael Skrzypczak. Republican candidate Christine E. Pontoriero articulated a pro-life position during a meeting with People for Life president Tim Broderick. However, no response to the PPLF PAC questionnaire has been received from Pontoriero as of this writing. Republican Randy Brewer, who is in the race as a write-in candidate, did respond to the questionnaire, indicating a pro-life position. Brewer is widely known throughout the Erie area, particularly by talk-radio listeners, for his solid pro-life convictions.

(2) State Rep. John Evans has a solid pro-life voting record. He submitted pro-life responses to the PPLF PAC questionnaire. No response has been received from any of the other three candidates in this race. However, in a conversation with a People for Life member during a candidate forum in Meadville, one of the other Republican candidates, Carol Loll, reportedly declined to describe herself as "pro-life" and said that the permissibility of abortion should be decided on a case by case basis.
