does not follow all the rules of the event. My child is a voluntary participant of this event and in good  
physical condition. I know that this event is a potentially hazardous activity and I hereby voluntarily  
assume full and complete responsibility for, and the risk of, any injury or accident that may occur during  
my child's participation in this event or while he/she is on the premises of this event.

I, for myself, my next of kin, minor children, heirs, executors, and administrators hereby release and hold  
harmless and covenant not to file suit against People for Life, Inc. or its sponsors, agents, employees of  
volunteers, and all other persons or entities associated with this event, including Burch Farms,  
(collectively "THE RELEASEES") for any injury or damages my child might suffer in connection with  
his/her participation in this event or while on the premises of this event.

This release applies to any and all loss, liability, or claims I or my child may have arising out of  
participation in this event including but not limited to, personal injury or damage suffered by my child or  
others, whether such losses, liabilities or claims be caused by falls, contact with and/or the actions of  
other participants, contact with fixed or non-fixed objects, contact with animals, conditions of the premises  
of the event, negligence of THE RELEASEES, risks not known to me or not reasonably foreseeable at  
this time or otherwise.
