## PA Life Amendment

The abortion industry, led by Planned Parenthood and the Women's Law Project extremist groups, have brought a law suit before the Pennsylvania Supreme Court claiming that the constitution of Pennsylvania requires the state to pay for elective abortions. The suit is based on the premise that abortion is nothing more than routine health care and that applying any restrictions or special regulations on the practice amounts to unconstitutional discrimination that targets women. It is likely that the state Supreme Court will rule in favor of the abortion industry in the near future, discovering that there is a fundamental right to abortion on demand hidden away in Pennsylvania's constitution. The decision could come at any time.

Not only will taxpayer funding of abortions be mandatory, significantly increasing the number of lives lost, but it will be practically impossible to protect babies even in the last three months of pregnancy. The Pennsylvania Abortion Control Act, with its common sense protections for unborn children and their mothers, will not survive. The Abortion Control Act, in force since the 1990s, requires that a woman be informed about the physical development of the baby and the availability of alternatives to

abortion, then given 24 hours to consider the information. The Abortion Control Act also ensures that at least one parent is involved in a minor daughter's abortion decision or that a judge determines, in extenuating circumstances, that the minor is mature enough to opt for abortion without a parent's involvement. Even the ability of state health regulators to conduct inspections of abortion facilities will be compromised.

The only sure way to prevent a disaster for the pro-life cause is for Pennsylvanians to amend their constitution and spell out in no uncertain terms that abortion is not a fundamental right in the Commonwealth.

Amending the Pennsylvania constitution is not a simple process. The amendment must be approved by majorities in the state House and state Senate, not once but twice, in two consecutive legislative sessions. Then it must be placed on the ballot in a general election and approved by a majority of the voters. Although it is a challenging procedure, it is possible that a strong, concerted effort will succeed, given that there are pro-life majorities in both the House and Senate. Fortunately, a constitutional amendment is not subject to a governor's veto.

Our first urgent tasks are to make sure the leaders in both House and Senate bring the amendment to a vote in a timely manner and to do everything possible to see that our own state representative and state senator vote to approve it. If all goes well, the process will be completed with the general election on November 7, 2023.

### Action Request

Please send an e-mail or letter to your legislators and for good measure make a phone call, too. Your basic message should be: Please support the Life Amendment to our state constitution. There is no right to abortion in our constitution, and that is the way it should be. The people of Pennsylvania deserve a chance to participate in the lawmaking process, especially in important matters that affect the lives of so many Pennsylvanians. The will of the people should not be overridden by the seven people on our state Supreme Court.

If you would like to mention the bill numbers, they are SB 956 for the Senate and HB 2252 for the House of Representatives.

### Define 'Pro-Life'

Let's take a closer look at our message. What

do we mean when we say "pro-life"? Simple! Killing any human being in an attempt to solve personal or societal problems is never permissible. You don't intentionally eliminate a human being to solve a problem.

### Vote Pro-Life?

So what does it mean to vote pro-life? This is not complicated either. It means that protecting and defending the fundamental right of every individual to continue living must be given the highest possible priority in every election. Being pro-life is a matter of practicing proper priorities; it is much more than just agreeing with a certain opinion. Voting to improve the quality of life, for others or even for oneself, is entirely legitimate, but not if it undercuts the right to life. To consciously choose quality of life over life itself is an abhorrent inversion of proper priorities.

### Why a 'political' message?

In our democratic republic, the voters, or more precisely, all those who are eligible to vote, are ultimately responsible for ensuring that all members of society are treated justly and that basic human rights are never desecrated. Politics is one of the most important means by which we look out for one another. When we vote, we must never forget that we are indeed our brother's and sister's keeper, to use a biblical allusion. Each of us must decide whether the most fundamental human right and the dignity of human life are essential or optional. We, the people of the United States and residents of Pennsylvania, have been given the power to govern. The question is this: Shall we govern responsibly or rule as narrow-minded tyrants?

### Single-Issue Voter?

But you are not going say you are a one-issue voter, are you? The answer should be a resounding, YES, of course, I am. When lives hang in the balance, when hundreds of thousand of lives hang in the balance as in the case of legalized abortion, we have a solemn duty to be single issue voters. If anyone challenges this, please ask them, What other issues would be more important to you, if it were your life that hung in the balance?

### Target Audience

We don't live in a perfect world, and unfortunately no billboard message will ever convince or compel the entire population to embrace our single-issue convictions. So what can we hope to accomplish with billboards? Are they a good idea, or not?

It is disheartening, but polling shows that only about 10% of American voters make protecting the unborn the top priority when they vote. This is disheartening. Beyond this 10% are many people who should know better, people who already understand that abortion is a grave act of violence that kills an innocent child. Some of these people are so passionate that they even use pro-life bumper stickers and pray daily to God about abortion. Yet they are not even registered to vote.

There are many excuses. Some people say their vote will not make a difference, even though we have all heard about elections that were decided by just a handful of votes, or even a single vote. Some think that abortion is legal (through all nine months in many places) because the majority of Americans want it that way. They forget that abortion was legalized by only seven men on the U.S. Supreme Court

who forced their opinion on the rest of America. To this very day only about 10% of Americans fully agree with Roe v. Wade, at least not after they find out what the decision actually says and how extreme it really is. Others feel like they are all alone in their convictions and that our nation's blindness to the evil of abortion too engrained. What if the opponents of slavery or segregation thought that way? Pro-life billboards and yard signs can help assure these pessimistic people that they are far from alone. Still others have been hoodwinked by those who deliberately and cynically distort the term "pro-life" to comport with their personal political agenda. That is why our billboards are worded to go directly to the heart of the matter: Abortion Hurts Everyone.

The billboards will be a resounding success if they do nothing more than motivate a small subset of voters to take human life issues more seriously, thereby encouraging them to reevaluate their priorities. Likewise, if the billboards help more pro-life people recognize the connection between "being pro-life" and VOTING, it will be an accomplishment.

### Pro-Abortion Backlash?

But won't highlighting human life issues and opposition to abortion mobilize pro-abortion voters just as much as pro-life voters? Not likely.

First of all, polls show that single issue pro-abortion voters are even more unusual than single issue pro-life voters. Abortion advocates often insist that "no one is pro-abortion." There is some truth to this, even though there are plenty of people who are indeed pro-abortion in every sense of the term. But it is not easy to be completely in the tank for baby-killing.

In the 15th Congressional District, Glenn Thompson (R) is unopposed. He has a 100% pro-life voting record, is no less passionately pro-life than his colleague Mike Kelly, and has also been a frequent guest at the Pro-Life Breakfast.

The only state Senate race in our area this year is in the 50th District, south of Erie County. In that race, Michele Brooks (R) has a 100% pro-life voting record and is a frequent sponsor of pro-life legislation. She has spoken at the Pro-Life Breakfast and was the keynote speaker at the Erie March for Life a few years ago. Rianna Czechos (D) position is not known, but she is supported by the pro-abortion Run for Something PAC.

Here is what we know about the candidates for the state House. ★ In the 1st District, incumbent Pat Harkins (D) voting record is pro-abortion. Challenger Andre Horton (D) position is unknown. ★ 2nd District incumbent Bob Merski (D) voting record is pro-abortion. Challenger Paul Pitonyak (R) position is unknown. ★ 3rd District incumbent Ryan Bizzarro (D) is pro-abortion, and, sadly, very stridently so.

The pro-life position offers love, hope, true compassion, and unlimited possibilities. The pro-abortion side offers nothing but a dead baby and empty arms. The truth is, life holds no guarantees, but abortion holds no possibilities.

So what about all the people who don't yet embrace our entire pro-life vision but do know, deep down, that abortion is not a good thing, those who realize that their pro-life friends do, at least, have a point? For some of these people, voting pro-life might mean choosing the pro-life candidate over the extremist candidate who cheers for third trimester abortions or thinks that the public schools should teach children that "Abortion is Health Care." For others, who might understand the heartbreak of abortion from personal experience, it could mean choosing the pro-life candidate over the pro-abortion candidate that would do away with common sense protections for women such as informed consent, parental consent, and one day waiting period regulations. Still others might draw the line at pro-abortion politicians who vow to use our tax dollars to pay for abortions as casually as if they were no different than an eye exam.

### The Life Amendment

The Pennsylvania Life Amendment is expected to be on the ballot in 2023. Anyone who votes for the Life Amendment, whether they wear the 100% pro-life label or not, will be casting a vote of epic pro-life importance. The Life Amendment will not make a single abortion illegal, but it will stop our opponents from expunging every commonsense law and regulation that pro-life Pennsylvanians have struggled to enact over the last 50 years. So, let's mainstream the message: Vote Pro-Life!

### Statewide Candidates

Here is where the statewide primary candidates stand, according the Pennsylvania Pro-Life Federation. In the race for governor, all nine Republican candidates are identified as pro-life. The single Democratic candidate, Josh Shapiro is identified as pro-abortion. In the race for lieutenant governor, all nine Republican candidates are pro-life. There are three candidates on the Democratic side. Austin Davis and Brian Sims are pro-abortion. Raymond Sosa's position is unknown. Brian Sims once videoed himself harassing a mother and daughter who were attempting to sidewalk counsel in front of an abortion facility. In the race for U.S. Senate, six of the seven Republican candidates are identified as pro-life and the position of one, Mehmet Oz, is reported as unknown. Oz was decidedly supportive of abortion in 2019 but now says he thinks of himself as "pro-life." All five Democratic candidates are identified as pro-abortion.

## Election: Congress and PA General Assembly

We sent a questionnaire to each candidate. Incomplete information may be due to the lack of a response. Some ratings are based on the PA Pro-Life Federation 2020 Voter Guide.

In the 16th Congressional District, incumbent George J. "Mike" Kelly (R) has a 100% pro-life voting record. He is passionately pro-life. Since first elected in 2010, Mike Kelly has never missed our Pro-Life Breakfast, a long winter's drive from his hometown of Butler. He has been a featured speaker at the Washington, DC March for Life. Richard Telesz (D) position is unknown, but we did receive an email in response to our questionnaire. It was a CC of a message from Telesz's political consulting company, with a curious notation: "Nah.. these are the prolife people." Dan Pastorek (D) position is clear, according to a report from KDKA in Pittsburgh: "I do believe in a woman's right to choose, and the issue should be decided between a woman and her health care providers."

# Patricia Sandoval: 2023 Pro-Life Breakfast Speaker

The huge loss of life and the tragic deadening of our collective sense of right and wrong, good and evil are not the only tragedies. There are also

the women, haunted by their abortion experiences and in some cases completely submerged in a black abyss where life is cheap and existence is ultimately meaningless. But there is hope and transformation! This is the story of Patricia Sandoval.

Gregory Hayes (R) is pro-life. He attends the Pro-Life Breakfast and occasionally visits our office. Joseph Concilla (R) returned a questionnaire with all pro-life responses. During a visit to People for Life several weeks ago, he took a strong pro-life position. ★ In the 6th District, incumbent Brad Roae (R) has a 100% pro-life voting record and is a frequent guest at the Pro-Life Breakfast. The positions of John Diamond (D) and Nerissa Galt (D) are unknown. ★ In the 7th District, incumbent Parke Wentling (R) has a 100% pro-life voting record and is a frequent Pro-Life Breakfast attendee. Mitchel Henderson (D) position is unknown. Timothy McGonigle (D) returned pro-life responses to our questionnaire, except for noting support for exceptions in cases of rape, incest, and when the mother's life is compromised due to the pregnancy. ★ In the 65th District, incumbent Kath Rapp (R), is unopposed. She is the co-chair of the House Pro-Life Caucus and a primary sponsor of many important pro-life bills. Also a the Pro-Life Breakfast attendee, she has a 100% pro-life voting record.

**Party State Committee Races**

We mailed questionnaires to the 27 Democratic and Republican candidates from Erie and Crawford counties who are running to serve on their party's state committee. Five Republicans provided 100% pro-life responses: B. Eddie, C. Greig, G. Greig, R. McGregor, and L. Pezino; J. Pepper's response leaned pro-life. T. Kuzma has returned 100% pro-life questionnaires in several previous election cycles. Of the other Republicans with whom we are familiar we think it is pretty safe to assume that J. Friend, R. Smith, and S. Sterrett also hold pro-life positions.

None of the Democratic candidates responded. However, one of them, Kristy Gribus, made her pro-abortion views very public when she ran for Congress against Mike Kelly in 2020.
